| 2. | Is an organization eligible to submit a bid for the tender, despite not attending the briefing session? | As stated in the paragraph 29.1 of the RFP document, the proposal of a bidder that fails to attend the compulsory online briefing session will not be considered for evaluation. |
| 3. | What are necessary documents that need to be submitted? | Please refer to the RFP document for all the documents to be submitted. |
| | How should the price schedule be completed? | Bidders must provide proposed rates in line with the detailed scope of work for categories of recruitment services in percentage (%) terms. The proposed rates (%) MUST be inclusive of all service offering for year 1-5. |

| 5. | Our company is a level 2 QSE with only 15% black ownership and will therefore score 0 points. Is it worth it to submit a response or will we immediately be disqualified? | A company/bidder will not immediately be disqualified for not meeting the set specific goals. However, they will not claim preference points for the set goals. |
| 6. | Is APSO registration sufficient for the submission of our tender, given that our PEA certificate has expired and is currently in progress? Are bidders allowed to submit the tender before the 27th of September 2024? | Submission of a valid Private Employment Agency (PEA) certificate as issued by the Department of Employment and Labour for the bidding company is mandatory . A bidder's registration with the Federation of African Professional Staffing Organisations (APSO) or related will not be accepted in the place of a valid PEA. Bidders must submit their proposal on or before the set closing date and time. Please refer to erratum one for the revised closing details. |
