- Bidders must present proof that their facility is approved/endorsed by the SAQCC to present the training.

#### 3 Additional requirements

- Clearly indicate VAT charged where applicable (if not VAT registered please state so clearly
- Provide a certified copy of a valid B-BBEE Certificate, or valid sworn affidavit indicating the B-BBEE Status level. B-BBEE certificate must be issued by SANAS accredited agency or a valid sworn affidavit in line with DTIC regulations.

#### 5 EVALUATION CRITERIA

- 5.1 Selection of suppliers will be based on the 80/20 preference point system.
- 5.2 Indicate valid B-BBEE status on quotation (SANAS). No B-BBEE status will equal zero points.
- 5.3 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use <u>www.csd.gov.za</u> to register.
- 5.4 No order will be issued or no contract will be signed without a valid CSD number.

#### 6 PRICING QUOTATION

- 6.1 Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 6.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 6.3 Payment will be according to the CSIR Payment Terms and Conditions.

#### 7 TRAVEL EXPENSES

- 7.1 All travel expenses for the CSIR's account, be it directly via the CSIR's travel agent or indirectly via re-imbursements, must be in line with the CSIR's travel policy. The following will apply:
  - 7.1.1 Only economy class tickets will be used.
  - 7.1.2 A maximum of R1400 per night for accommodation, dinner, breakfast and parking will be allowed.
  - 7.1.3 No car rentals of more than a Group B will be accommodated.

### 8 OTHER TERMS AND CONDITIONS

- 8.1 The supplier shall under no circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such an act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.
- 8.2 A validity period of 90 days will apply to all quotations except where indicated differently on the quote.
- 9 No goods and/or services should be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to supplier.
- 10 Note: This is not a Purchase Order.
