1 INVITATION FOR QUOTATION

The supply of Memmert Vacuum Oven to the CSIR

2 QUOTATION REQUIREMENTS

All quotations must include the following:

2.1 Memmert Vacuum Oven with model size 49. Stainless steel with height 385 and depth 330 mm and maximum loading per thermoshel of 20. Working temp +20 to 200.

3 EVALUATION CRITERIA

- 3.1 Selection of suppliers will be based on the 80/20 preference point system.
- 3.2 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use <u>www.csd.gov.za</u> to register.
- 3.3 No order will be issued, or no contract will be signed without a valid CSD number.
- 3.4 No B-BBEE scores will be allocated to service providers if they do not provide the following:

- Provide valid certified copy of the B-BBEE Certificate issued by an accredited verification agency and bearing a SANAS logo; or
- Valid sworn affidavits made on DTIC designed templates; or
- DTIC issued affidavit; or
- 3.5 Quotations must be submitted on company letterhead.

4 ELIMINATION CRITERIA

- Late submission of quotes;
- Submission at the wrong location or incorrect email address (Please submit electronically to <u>tender@csir.co.za</u>)
- Non-submission of quotes on company letterhead.
- Bidders that do not submit a fully completed and signed SBD 1 and SBD 4
 Form will not be considered

5 PRICING QUOTATION

- 5.1 Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 5.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 5.3 Payment will be according to the CSIR Payment Terms and Conditions.

6 OTHER TERMS AND CONDITIONS

- 6.1 The supplier shall under no circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such an act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.
- 6.2 The e-mail and file sizes should not exceed a total of 25MB per e-mail.

6.3 A validity period of 90 days will apply to all quotations except where indicated differently on the quote.

- 7 No goods and/or services should be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to supplier.
