# 1 INVITATION FOR QUOTATION

Quotations are hereby requested for a Rotary Screw Oil Compressor.

#### 2 SPECIFICATIONS

Bidders are requested to quote for a Rotary Screw Oil Compressor with the following specifications:

# **Description:**

- Rotary screw oil compressor
- Power: 15kW compressor,
- 10 Bar Rated and
- produce 2.26 m3/min of air
- This compressor must be supplied with:
- an activated carbon tower consisting of particulate AA filter to remove solid oil and vapor to 0.003 mg/m3

## 3 EVALUATION CRITERIA

- 3.1 Selection of suppliers will be based on the 80/20 preference point system.
- 3.2 Submit a valid B-BBEE Certificate (SANAS accredited) or sworn affidavit (CIPC or Dtic template) indicating the B-BBEE Status level. (RSA suppliers only)
- 3.3 No B-BBEE status will equal zero points. (RSA suppliers only)
- 3.4 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use www.csd.gov.za to register.
- 3.5 No order will be issued, or no contract will be signed without a valid CSD number (Only applicable to RSA suppliers).

## 3.6 Elimination Criteria:

Suppliers will be eliminated under the following conditions:

- Late submission of Quotes;
- Submission at the incorrect email address- submissions must be made to tender@csir.co.za
- If bidder does not submit quotation on official company letterhead.
- Bidders that submit late bids will not be considered.
- Bidders that are listed on the NT database of restricted suppliers will not be considered.
- Bidders that are registered on the NT Register of Tender Defaulters will not be considered.
- Bidders that do not submit a fully completed and signed SBD 1 and SBD 4 Form will not be considered.

#### 4 PRICING QUOTATION

- 4.1 Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated, if applicable.
- 4.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 4.3 Payment will be according to the CSIR Payment Terms and Conditions.

The price should be firm and inclusive of costs and all services required to deliver on the required goods and/or services.
