# 1 INVITATION FOR QUOTATION

# 2 QUOTATION REQUIREMENTS

Supply of and delivery of washed and cleaned 3 tonnes wet/weight of African ginger rhizomes with roots attached to the CSIR.

# **3 EVALUATION CRITERIA**

- 3.1 Selection of suppliers will be based on the 80/20 preference point system.
- 3.2 Provide a valid copy of a B BBEE Certificate or valid sworn affidavit. No B BBEE status will equal to zero points. B BBEE certificate must be issued by SANAS accredited agency or a valid sworn affidavit in line with DTI regulations. (RSA suppliers only).
- 3.2.1 B BBEE Verification Agency issued the B BBEE Certificate can be verified on SANAS website on Verification Agency (B BBEE) under Accredited Facilities (Quick Access Links): https://www.sanas.co.za/Pages/index.aspx to check validity of the B BBEE Certificate. Submit a valid B-BBEE Certificate (SANAS accredited) or sworn affidavit (CIPC or Dtic template) indicating the B-BBEE Status level. (RSA suppliers only). No B-BBEE certificate / affidavit will equal zero points.

- 3.3 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use <u>www.csd.gov.za</u> to register.
- 3.4 No order will be issued or no contract will be signed without a valid CSD number.

## 4 ELIMINATION CRITERIA:

Suppliers will be eliminated under the following conditions:

- 4.1 Late submission of Quotes;
- 4.2 Submission at the incorrect email address- submissions must be made to tender@csir.co.za
- 4.3 If bidder does not submit quotation on official company letterhead.
- 4.4 Bidders that are listed on the NT database of restricted suppliers will not be considered.
- 4.5 Bidders that are registered on the NT Register of Tender Defaulters will not be considered.
- 4.6 Bidders that do not submit a fully completed and signed SBD 1 and SBD 4 Form will not be considered.

## 5 PRICING QUOTATION

- 5.1 Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.
- 5.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 5.3 Payment will be according to the CSIR Payment Terms and Conditions.

# 6 OTHER TERMS AND CONDITIONS

- 6.1 The supplier shall under no circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such an act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.
- 6.2 A validity period of 90 days will apply to all quotations except where indicated differently on the quote.

- 7 No goods and/or services should be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to supplier.
- 8 Note: This is not a Purchase Order.
