# 1 INTRODUCTION

The Council for Scientific and Industrial Research (CSIR) is one of the leading scientific research and technology development organisations in Africa. In partnership with national and international research and technology institutions, the CSIR undertakes directed and multidisciplinary research and technology innovation that contributes to the improvement of the quality of life of South Africans. The CSIR's main site is in Pretoria while it is represented in other provinces of South Africa through regional offices.

# 2 INVITATION FOR QUOTATION

Quotations are hereby invited for the provision of catering services for the 44<sup>th</sup> Habitable Planet Workshop to be held in North West at University Potchefstroom Campus, 2-10 December 2024.

The workshop will be a 8-day event involving +/- 55 delegates with exact dates/numbers to be confirmed. The specifications provided here are the maximum anticipated; the CSIR reserve the right to contract the winning bidder for a portion of the work requested here. Should this be portion be greater than 50% of total value of the quotation, the unit price (i.e. price per meal) for this portion must remain the same initially quoted.

# 3 SPECIFICATION / SCOPE OF WORK / TERMS OF REFERENCE

In summary the CSIR are looking to procure catering services from a service provider with a clearly demonstrated record of catering for large events, with the following outline specifications:

- 55 pax
- 2-10 December 2024.
- First meal is dinner on the 2<sup>nd</sup>.
- Final meal is breakfast on the 10<sup>th</sup>.
- Location is the North West University Potchefstroom Campus
- Delivering the following meals daily:
  - o Breakfast
  - o Morning tea
  - o Lunch
  - o Afternoon tea
  - o Dinner

Please note that only bids from companies with a proven track record of catering for events of similar scale, and who show catering/cooking/food supply/event management company as the company's primary objective/trade/business on their registration with CIPC and CSD, will be considered.

Detailed specifications of the work are outlined under Annexure A

# 4 OBJECTIVE CRITERIA

The CSIR reserves the right to award this tender to a bidder that did not score the highest total number of points in accordance with Section (2) (1) (f) of the PPPFA (Act 5 of 2000)", under the following conditions:

• The directors, shareholders or officers of the bidder must not be formally accused of fraudulent or illegal conduct which could harm the CSIR's reputation by associating with the bidder.

# 5 PRICING REQUIREMENTS

- 5.1 Pricing must be provided in South African Rand (including all applicable taxes less all unconditional discounts).
- 5.2 Prices that are subject to escalation and exchange rate fluctuations are to be clearly indicated, with the currency and ROE used in the quotation must be clearly indicated.
- 5.3 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 5.4 Payment will be according to the CSIR Payment Terms and Conditions (Link).
- 5.5 Please provide a detail pricing using a Pricing Schedule/Bill of Quantities outlined under Annexure B

Bidders are to price their quotations using the Pricing Schedule. Explanatory notes must be provided in the quotation when deviating from the Pricing Schedule.

# 6 RETURNABLES

Returnables are required for evaluation purposes. Bidders' responses will be evaluated based on compliance with the listed administration and mandatory bid requirements. The bidder(s) proposal may be disqualified for non-submission of any of the documents.

# 7 EVALUATION PROCESS AND CRITERIA

The RFQ will be evaluated as per the following:

# Phase 1 – Elimination Criteria

The bidders will be evaluated on the elimination criteria as stated in Point 7.1 below. Bidders that are eliminated during this phase will not be evaluated further on price and preference points.

# Phase 2 – Price and Preference Points Evaluation

Bidders will be evaluated as per the preference points system stated in point 7.2 below.

# 7.1 Elimination Criteria

Bidders will be eliminated if they fail to provide the following information:

- a) Bidders that submit late bids will not be considered.
- b) Bidders that submit to the incorrect location or email address will not be considered.
- c) Bidder that are listed on the NT database of restricted suppliers will not be considered.
- d) Bidders that are registered on the NT Register of Tender Defaulters will not be considered.
- e) Bidder that did not submit mandatory returnable documents.
- f) Bidders that fail to meet the specification requirements will not be considered.

# 7.2 **Preferential Points System Evaluation Criteria**

Selection of suppliers will be based on the 80/20 preference point system as stipulated in **Annexure E: Preference Points Award Form**.

# 8 SUBMISSION REQUIREMENTS

- 8.1 All quotations must be submitted electronically to <u>tender@csir.co.za</u>
- 8.2 Respondents must use the RFQ number and RFQ Description as the subject reference number when submitting their bids.
- 8.3 The email and file sizes must not exceed a total of 25MB per email.
- 8.4 Documents submitted via cloud solutions such as: WeTransfer, Google Drive, Dropbox, etc. will not be considered.
- 8.5 The naming / labelling syntax of files or documents must be short and simple.

# 9 MEDIUM OF COMMUNICATION

All documentation submitted in response to this RFQ must be in English.

# 10 CORRECTNESS OF RESPONSES

- 10.1 The bidder must confirm satisfaction regarding the correctness and validity of their proposal and that all prices and rates quoted cover all the work/items specified in the RFQ. The prices and rates quoted must cover all obligations under any resulting contract.
- 10.2 The bidder accepts that any mistakes regarding prices and calculations will be at their own risk.

# 11 VERIFICATION OF DOCUMENTS

- 11.1 Bidders should check the numbers of the pages to satisfy themselves that none are missing or duplicated. No liability will be accepted by the CSIR in regard to anything arising.
- 11.2 Pricing schedule and specific goals credentials should be submitted with the RFQ response.

# 12 PREPARATION COSTS

The Bidder will bear all its costs in preparing, submitting and presenting any response or Tender to this bid and all other costs incurred by it throughout the bid process. Furthermore, no statement in this bid will be construed as placing the CSIR, its employees or agents under any obligation whatsoever, including in respect of costs, expenses or losses incurred by the bidder(s) in the preparation of their response to this bid.

# 13 OTHER TERMS AND CONDITIONS

- 13.1 No bidder shall under any circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such an act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.
- 13.2 Bidders shall not assume that information and/or documents supplied to CSIR, at any time prior to this request, are still available to CSIR, and shall consequently not make any reference to such information document in its response to this request.
- 13.3 Changes by a bidder to its submission will not be considered after the closing date and time.
- 13.4 Bidders confirm that by submitting a tender, they confirm that I am satisfied with regards to the correctness and validity of my quotation; that the price(s) and rate(s) quoted cover all the services specified in the quotation documents; that the price(s) and rate(s) cover all my obligations and I accept that any mistakes regarding price(s) and rate(s) and calculations will be at my own risk.
- 13.5 Bidders further confirm that by submitting a tender, they accept to take accept full responsibility for the proper execution and fulfilment of all obligations and conditions devolving on them under this RFQ as the principal liable for the due fulfilment of this RFQ process.
- 13.6 No goods and/or services shall be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to the supplier.

### 14 SPECIAL CONDITIONS

The CSIR reserves the right to

- Extend the closing date of this RFQ;
- Correct any mistakes at any stage of the tender that may have been in the Bid documents or occurred at any stage of the tender process;
- Verify any information contained in the bidder's submission;
- Request documentary proof regarding the bidder's submission;
- Carry out site inspections, product evaluations or explanatory meetings in order to verify the nature and quality of the product/service offered by the bidder(s) or verify any information whether before or after the adjudication of this RFQ;
- Award this tender to a bidder that did not score the highest total number of points, only in accordance with Section 2(1)(f) of the PPPFA (Act 5 of 2000);
- Award this RFQ as a whole or in part, retaining the same cost per meal, should that part be greater than 50% of the quotation value;
- Award this RFQ to multiple bidders;
- Cancel and/or terminate the tender process at any stage, including after the Closing Date and/or after presentations have been made, and/or after tenders have been evaluated and/or after the preferred bidder(s) have been notified of their status as such.

# 15 CONFIDENTIALITY

Some of the information contained in the Tender Documents may be of a confidential nature and must only be used for purposes of responding to this RFQ. This confidentiality clause extends to bidder partners whom you may decide to involve in preparing a response to this RFQ. Bidders must complete and sign **ANNEXURE F:** Non- Disclosure Agreement.

Except as may be required by operation of law, by a court or by a regulatory authority having appropriate jurisdiction, no information contained in or relating to this bid or a bidder's tender(s) will be disclosed by any bidder or other person not officially involved with the CSIR's examination and evaluation of a Tender.

No part of the bid may be distributed, reproduced, stored or transmitted, in any form or by any means, electronic, photocopying, recording or otherwise, in whole or in part except for the purpose of preparing a Tender. This bid and any other documents supplied by the CSIR remain proprietary to the CSIR and must be promptly returned to the CSIR upon request together with all copies, electronic versions, excerpts or summaries thereof or work derived there from.

Throughout this bid process and thereafter, bidder(s) must secure the CSIR's written approval prior to the release of any information that pertains to (i) the potential work or activities to which this bid relates; or (ii) the process which follows this bid. Failure to adhere to this requirement may result in disqualification from the bid process and civil action.

# 16 PROTECTION OF PERSONAL INFORMATION

- 16.1 Each Party consents to the other Party holding and processing "personal information" (as defined in the POPI Act) relating to it for legal, personnel, administrative and management purposes (including, if applicable, any "special personal information" relating to him/her, as defined in the POPI Act). Notwithstanding the generality of the aforesaid, each Party hereby undertakes to comply with all relevant provisions of the POPI Act and any other applicable data protection laws. The Client further agrees to comply with all CSIR's reasonable internal governance requirements pertaining to data protection.
- 16.2 Each Party consents to the other Party making such information available to those who provide products or services to such parties (such as advisers, regulatory authorities, governmental or quasi-governmental organisations and potential purchasers of such Party or any part of their business).
- 16.3 The Client consents to the transfer of such information to CSIR's business contacts outside South Africa in order to further its business interests.
- 16.4 While performing any activity where a Party is handling personal information as a "responsible party" (as defined in the POPI Act), each Party undertakes that it will process the personal information strictly in accordance with the terms of the POPI Act, this Contract, and the other Party's instructions from time to time, and take appropriate operational measures to safeguard the data against any unauthorised access.
- 16.5 Each Party acknowledges that in the course of conducting business with each other, each Party intends to maintain and process personal information about the other Party in an internal database. By signing this Contract, each Party consents to the maintenance and processing of such personal information.
- 16.6 Where relevant, the Client shall procure that all of its personnel, agents, representatives, contractors, sub-contractors and mandataries shall comply with the provisions of this clause 16 (Personal Information). The CSIR shall be entitled on reasonable notice to conduct an inspection or audit Client's compliance with the requisite POPI Act safeguards.

# 17 INDEMNITY

If a bidder breaches the conditions of this bid and, as a result of that breach, the CSIR incurs costs or damages (including, without limitation, the cost of any investigations, procedural impairment, repetition of all or part of the bid process and/or enforcement of intellectual property rights or confidentiality obligations), then the bidder indemnifies and holds the CSIR harmless from any and all such costs which the CSIR may incur and for any damages or losses the CSIR may suffer.

# 18 LIMITATION OF LIABILITY

A bidder participates in this bid process entirely at its own risk and cost. The CSIR shall not be liable to compensate a bidder on any grounds whatsoever for any costs incurred or any damages suffered as a result of the Bidder's participation in this Bid process.

# 19 MISREPRESENTATIONS DURING THE LIFECYCLE OF THE CONTRACT

- 19.1 The bidder should note that the terms of its Tender will be incorporated in the proposed contract by reference and that the CSIR relies upon the bidder's Tender as a material representation in making an award to a successful bidder and in concluding an agreement with the bidder.
- 19.2 It follows therefore that misrepresentations in a Tender may give rise to service termination and a claim by the CSIR against the bidder notwithstanding the conclusion of the Service Level Agreement between the CSIR and the bidder for the provision of the Service in question. In the event of a conflict between the bidder's proposal and the Service Level Agreement concluded between the parties, the Service Level Agreement will prevail.

# 20 DISCLAIMER

This RFQ is a request for Quotations only and not an offer document. Answers to this RFQ must not be construed as acceptance of an offer or imply the existence of a contract between the parties. By submission of its proposal, bidders shall be deemed to have satisfied themselves with and to have accepted all Terms & Conditions of this RFQ. The CSIR makes no representation, warranty, assurance, guarantee or endorsements to bidder concerning the RFQ, whether with regard to its accuracy, completeness or otherwise and the CSIR shall have no liability towards the bidder or any other party in connection therewith.

# 21 NATIONAL TREASURY CENTRAL SUPPLIER DATABASE

- 21.1 Bidders are required to be registered on the Central Supplier Database and the National Treasury shall verify the bidder's tax compliance status through the Central Supplier Database. Registrations can be completed online at: <a href="http://www.csd.gov.za">www.csd.gov.za</a>;
- 21.2 Where Consortia / Joint Ventures / Sub-contractors are involved, each party must be registered on the Central Supplier Database and their tax compliance status will be verified through the Central Supplier Database.

# Annexure A Specification / Scope of Work / Terms of Reference

- 1. The maximum scope of work required by the CSIR, and the basis for quotation in this tender, is catering for 55 pax, that is the same or comparatively similar to the specifications below.
- 2. This is a student workshop and therefore we are expecting food that is simple, healthy, filling and cost effective.
- 3. There will be special diets that will need to be catered for (e.g. Vegan, Vegetarian, Halal) and numbers of these will be confirmed (one) 1 month before the start of the workshop.
- 4. The menu is provided below serves as a guideline for the type and quantity of food that is required. Whereas the food served does not have to be exactly as per this menu, this suggests the expected type of dishes and minimum standard and quantity required. All quotations should reflect this.
- 5. The contract will only be awarded to the supplier that can demonstrate their record with both written references and photos.
- 6. Service providers are requested to appoint a project manager with contact details and must be available for the duration of the project.
- 7. Service providers must dedicate sufficient staff to the project such that meals can cooked, delivered served and dishes cleared up efficiently.
- 8. Only service providers with sufficient cashflow to procure and supply quality ingredients for delivery of the work, prior to CSIR payment 45 days after the work is completed, will be considered. An affidavit is required (see Table 2 in section 6.2 above) to attest to this.

# General requirements for all meals

- 1. All meals to be served with Oros (or juice/cool drinks) and water along with the same selections.
- 2. All meals must be served with appropriate crockery, utensils and cutlery. This must include a spoon/fork/spork with all meals and a knife if any item of the food needs cutting.
- 3. All meals need to be served between 60-70 °C unless indicated as a packed meal to be served cold.
- 4. All meals must be served with appropriate sides and condiments to make them palatable. E.g. Cereals need to be served with a suitable quantity of milk, main dishes to be served with salt, pepper and sauces.
- 5. All meals to be served buffet style unless otherwise indicated (some meals are packed for field trips see below)

# Template Menu

# A. Breakfast

- 1. Cooked breakfast (featuring at least three of: Bacon (2 full rashers each), eggs (2 each), sausages (2 each), beans (4 tbps each), tomatoes (1 full large tomato each) with toast (2 slices each).
- 2. Option of oats, fruit and cereals on the side.
- **3.** Juice to drink along with the same selections of tea/coffees as for tea breaks.

# B. Morning / afternoon tea break

Provide the following twice a day:

- Selection of tea bags: 5 roses and rooibos
- Coffee Granules
- Hot water 80-100 degrees
- Milk or milk powder for 55 cups of tea or coffee
- Sugar
- One Sweet Snack (at least 1 pp): Muffin, biscuits or cakes.
- One more healthy snack(at least 1 pp): e.g. Sandwich, bran muffin or fruit
- Drinking water and cups

# Day 1:

Packed dinner: Grilled Chicken (250 g pp), rice, pap (no salt added), creamed spinach, small side salad.

# Day 2:

*Lunch:* Chicken/mutton pie (220g), hot chips/mashed potatoes/roast potatoes, side salad. *Dinner:* Beef Stew (350g pp), Umngqusho, pap (no salt added), butternut, small side salad.

# Day 3:

Lunch (packed for field trip): 2 x Tuna/Chicken Mayo Sandwich with lettuce and tomato, Bar one/muesli bar, Simba Chips/peanuts, whole piece of fruit, juice pack, bottled water Dinner: Butter Chicken Curry (extra mild, 350g pp), rice, pap, small side salad

### MUTUAL NON-DISCLOSURE AGREEMENT

#### 1 Preamble

The Parties as identified herein are engaged in discussions relating to their potential collaboration in the Field as likewise described therein; are by virtue thereof are required to disclose Confidential Information to one another, and have agreed to do so subject to the terms and conditions as set out in this agreement.

#### 2 Definitions

- 2.1 The following words and/or phrases, when used in this agreement, shall have the following meanings:
- 2.1.1 "Confidential Information" shall mean all scientific, technical, business, financial, past, present or future research, development, business activities, products, services and technical knowledge or marketing information, whether inside or outside the Field, which one party (the "Disclosing Party") discloses to the other party (the "Receiving Party") in connection with the discussions, and either has been identified in writing as confidential or is of such a nature (or has been disclosed in such a way) that it should be obvious to the Receiving Party that it constitutes Confidential Information. (Without limiting the generality of the aforegoing, "Confidential Information" shall include any information that falls within the definition of 'Personal Information'
- 2.1.2 "Disclosing Party" shall mean the Party disclosing Confidential Information under this agreement;
- 2.1.3 "Disclosing Purpose" shall mean, as pertains to any particular joint opportunity(ies) in the Field, the discussions held or to be held between the Parties regarding their possible collaboration and future working relationship with regards to any such opportunity(ies);
- 2.1.4 "Effective Date' shall mean the date of the commencement of this agreement herein";
- 2.1.5 "Notice" shall mean a written document addressed by one Party to the other and either delivered by hand; sent per registered post or telefaxed to the addresses as indicated herein";
- 2.1.6 "Personal Information" means any information that falls within the definition of 'Personal Information' as defined in the Protection of Personal Information Act, No 4 of 2013 ("POPI");
- 2.1.7 "Receiving Party" shall mean the Party receiving Confidential Information under this agreement;

"Responsible Party" means a public or private body or any other person which, alone or in conjunction

with others, determines the purpose of and means for processing personal information, as defined in POPI.

#### 3 Obligation of Confidentiality

- 3.1 The Receiving Party undertakes and agrees:

- 4 Protection of Personal Information
- 4.1 The Party(ies) undertake(s) to:-
- 4.1.1 comply with the provisions of POPI as well as all applicable legislation as amended or substituted from time to time;
- 4.1.2 treat all Personal Information strictly as defined within the parameters of POPI;
- 4.1.3 process Personal Information only in accordance with the consent it was obtained for, for the purpose agreed, any lawful and reasonable written instructions received from the applicable Responsible Party and as permitted by law;
- 4.1.4 process Personal Information in compliance with the requirements of all applicable laws;
- 4.1.5 secure the integrity and confidentiality of any Personal Information in its possession or under © CSIR 2017 Version: July 2017

its control by taking appropriate, reasonable technical and organisational measures to prevent loss, damage, unauthorised destruction, access, use, disclosure or any other unlawful processing of Personal Information;

- 4.1.6 not transfer any Personal Information to any third party in a foreign country unless such transfer complies with the relevant provisions of POPI regarding transborder information flows; and
- 4.1.7 not retain any Personal Information for longer than is necessary for achieving the purpose in terms of this Agreement or in fulfilment of any other lawful requirement.
- 4.2 The Party(ies) undertake(s) to ensure that all reasonable measures are taken to:
- 4.2.1 identify reasonably foreseeable internal and external risks to the Personal Information in its possession or under its control;
- 4.2.2 establish and maintain appropriate security safeguards against the identified risks;
- 4.2.3 regularly verify that the security safeguards are effectively implemented;
- 4.2.4 ensure that the security safeguards are continually updated in response to new risks or deficiencies in previously implemented safeguards;
- 4.2.5 provide immediate notification to the Responsible Party if a breach in information security or any other applicable security safeguard occurs; provide immediate notification to the Responsible Party where there are reasonable grounds to believe that the Personal Information has been accessed or acquired by any unauthorised person;
- 4.2.6 remedy any breach of a security safeguard in the shortest reasonable time and provide the Responsible Party with the details of the breach and, if applicable, the reasonable measures implemented to address the security safeguard breach;
- 4.2.7 provide immediate notification to the Responsible Party where either party has, or reasonably suspects that, Personal Information has been processed outside of the purpose agreed to or consented to;
- 4.2.8 provide the Responsible Party, upon request, with all information of any nature whatsoever relating to the processing of the Personal Information for the purpose in terms of this Agreement and any applicable law; and
- 4.2.9 notify the CSIR, if lawful, of receipt of any request for access to Personal Information, in its possession and relating to the CSIR.
- 4.3 The CSIR reserves the right to inspect the Personal Information processing operations, as well as the technical and organisational information security measures employed by the contracting Party to ensure compliance with the provisions of clause 4.

- 5 Exclusions

- 5.1.2 it can show was in its possession prior to the earliest disclosure by the Disclosing Party, as evidenced by written documents in its files;
