1 INTRODUCTION

In partnership with national and international research and technology institutions, the CSIR undertakes directed and multidisciplinary research and technology innovation that contributes to the improvement of the quality of life of South Africans. The CSIR's main site is in Pretoria while it is represented in other provinces of South Africa through regional offices.

2 INVITATION FOR QUOTATION

Quotations are hereby invited for the Supply and delivery of 10x custom-made shipping containers (12mx3m) for the CSIR to be installed in Peddie town ,Eastern Cape.

3 SPECIFICATION

The more detailed specification is outlined under **Annexure A (Page 10-14)**

4 PRICING REQUIREMENTS

- 4.1 Pricing must be provided in South African Rand (including all applicable taxes less all unconditional discounts).
- 4.2 Prices that are subject to escalation and exchange rate fluctuations are to be clearly indicated, with the currency and ROE used in the quotation must be clearly indicated.
- 4.3 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 4.4 Payment will be according to the [CSIR Payment Terms and Conditions](#).
- 4.5 Please provide a detail pricing using a Pricing Schedule outlined under **Annexure B**.

Bidders are to price their quotations using the Pricing Schedule. Explanatory notes must be provided in the quotation when deviating from the Pricing Schedule.

5 RETURNABLES

6 EVALUATION PROCESS AND CRITERIA

The RFQ will be evaluated as per the following:

Phase 1 – Elimination Criteria

The bidders will be evaluated on the elimination criteria as stated in Point 6.1 below. Bidders that are eliminated during this phase will not be evaluated further on price and preference points.

Phase 2 – Price and Preference Points Evaluation

Bidders will be evaluated as per the preference points system stated in point 6.2 below.

6.1 Elimination Criteria

Bidders will be eliminated if they fail to provide the following information:

- a) Bidder that submits late bids will not be considered.
- b) Bidder that submits to the incorrect location or email address will not be considered.

- c) Bidder that is listed on the NT database of restricted suppliers will not be considered.
- d) Bidder that is registered on the NT Register of Tender Defaulters will not be considered.
- e) Bidder that did not submit mandatory returnable documents as listed on paragraph 5.2 (**Table 2**).
- f) Bidder that fails to meet the specification requirements will not be considered.

6.2 Preferential Points System Evaluation Criteria

Selection of suppliers will be based on the 80/20 preference point system as stipulated in **Annexure E: Preference Points Award Form**.

7 OBJECTIVE CRITERIA

The CSIR reserves the right to award this tender to a bidder that did not score the highest total number of points in accordance with Section (2) (1) (f) of the PPPFA (Act 5 of 2000)", under the following conditions:

- The directors, shareholders or officers of the bidder must not be formally charged of fraudulent or illegal conduct which could harm the CSIR's reputation by associating with the bidder.

8 SUBMISSION REQUIREMENTS

- 8.1 All quotations must be submitted electronically to tender@csir.co.za
- 8.2 Respondents must use the RFQ number and RFQ Description as the subject reference number when submitting their bids.
- 8.3 The email and file sizes must not exceed a total of 25MB per email.
- 8.4 Documents submitted via cloud solutions such as: WeTransfer, Google Drive, Dropbox, etc. will not be considered.
- 8.5 The naming / labelling syntax of files or documents must be short and simple.
- 8.6 **Costing Documentation: Detailed description of proposed design, materials, manufacturing process, and adherence to specifications.**
- 8.7 **Project Plan: Proposed timeline, resource allocation, and key milestones and final construction drawings and specifications needs to be supplied.**
- 8.8 **Quality Control Plan: Outline of quality assurance procedures during fabrication and testing.**
- 8.9 **Health and Safety Plan: Compliance with OHS Act and regulations.**
- 8.10 **Experience & References: Provide details of similar projects undertaken.**
- 8.11 **Certifications: Manufacturer's certifications, engineering certificates, material data sheets.**

9 MEDIUM OF COMMUNICATION

All documentation submitted in response to this RFQ must be in English.

10 CORRECTNESS OF RESPONSES

- 10.1 The bidder must confirm satisfaction regarding the correctness and validity of their proposal and that all prices and rates quoted cover all the work/items specified in the RFQ. The prices and rates quoted must cover all obligations under any resulting contract.
- 10.2 The bidder accepts that any mistakes regarding prices and calculations will be at their own risk.

11 VERIFICATION OF DOCUMENTS

- 11.1 Bidders should check the numbers of the pages to satisfy themselves that none are missing or duplicated. No liability will be accepted by the CSIR in regard to anything arising.
- 11.2 Pricing schedule and specific goals credentials should be submitted with the RFQ response.

12 PREPARATION COSTS

The Bidder will bear all its costs in preparing, submitting and presenting any response or Tender to this bid and all other costs incurred by it throughout the bid process. Furthermore, no statement in this bid will be construed as placing the CSIR, its employees or agents under any obligation whatsoever, including in respect of costs, expenses or losses incurred by the bidder(s) in the preparation of their response to this bid.

13 OTHER TERMS AND CONDITIONS

- 13.1 No bidder shall under any circumstances offer, promise or make any gift, payment, loan, reward, inducement, benefit or other advantage, which may be construed as being made to solicit any favour, to any CSIR employee or its representatives. Such an act shall constitute a material breach of the Agreement and the CSIR shall be entitled to terminate the Agreement forthwith, without prejudice to any of its rights.
- 13.2 Bidders shall not assume that information and/or documents supplied to CSIR, at any time prior to this request, are still available to CSIR, and shall consequently not make any reference to such information document in its response to this request.
- 13.3 Changes by a bidder to its submission will not be considered after the closing date and time.

- 13.4 Bidders confirm that by submitting a tender, they confirm that I am satisfied with regards to the correctness and validity of my quotation; that the price(s) and rate(s) quoted cover all the services specified in the quotation documents; that the price(s) and rate(s) cover all my obligations and I accept that any mistakes regarding price(s) and rate(s) and calculations will be at my own risk.
- 13.5 Bidders further confirm that by submitting a tender, they accept to take accept full responsibility for the proper execution and fulfilment of all obligations and conditions devolving on them under this RFQ as the principal liable for the due fulfilment of this RFQ process.
- 13.6 No goods and/or services shall be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to the supplier.

14 SPECIAL CONDITIONS

The CSIR reserves the right to

- 14.1. Extend the closing date of this RFQ;
- 14.2. Correct any mistakes at any stage of the tender that may have been in the Bid documents or occurred at any stage of the tender process;
- 14.3. Verify any information contained in the bidder's submission;
- 14.4. Request documentary proof regarding the bidder's submission;
- 14.5. Carry out site inspections, product evaluations or explanatory meetings in order to verify the nature and quality of the product/service offered by the bidder(s) or verify any information whether before or after the adjudication of this RFQ;
- 14.6. Award this tender to a bidder that did not score the highest total number of points, only in accordance with Section 2(1)(f) of the PPPFA (Act 5 of 2000);
- 14.7. Request audited financial statements or other documents for the purpose of a due diligence exercise to determine if the bidder will be able to execute the contract;
- 14.8. Award this RFQ as a whole or in part;
- 14.9. Award this RFQ to multiple bidders;
- 14.10. Cancel and/or terminate the tender process at any stage, including after the Closing Date and/or after presentations have been made, and/or after tenders have been evaluated and/or after the preferred bidder(s) have been notified of their status as such;
- 14.11. Post tender negotiate on any elements on the bid, including but not limited to technical, transformation, price, and contractual terms and conditions.;

15 CONFIDENTIALITY

Some of the information contained in the Tender Documents may be of a confidential nature and must only be used for purposes of responding to this RFQ. This confidentiality clause extends to bidder partners whom you may decide to involve in preparing a response to this RFQ.

Except as may be required by operation of law, by a court or by a regulatory authority having appropriate jurisdiction, no information contained in or relating to this bid or a bidder's tender(s) will be disclosed by any bidder or other person not officially involved with the CSIR's examination and evaluation of a Tender.

No part of the bid may be distributed, reproduced, stored or transmitted, in any form or by any means, electronic, photocopying, recording or otherwise, in whole or in part except for the purpose of preparing a Tender. This bid and any other documents supplied by the CSIR remain proprietary to the CSIR and must be promptly returned to the CSIR upon request together with all copies, electronic versions, excerpts or summaries thereof or work derived there from.

Throughout this bid process and thereafter, bidder(s) must secure the CSIR's written approval prior to the release of any information that pertains to (i) the potential work or activities to which this bid relates; or (ii) the process which follows this bid. Failure to adhere to this requirement may result in disqualification from the bid process and civil action.

16 PROTECTION OF PERSONAL INFORMATION

- 16.1 Each Party consents to the other Party holding and processing "personal information" (as defined in the POPI Act) relating to it for legal, personnel, administrative and management purposes (including, if applicable, any "special personal information" relating to him/her, as defined in the POPI Act). Notwithstanding the generality of the aforesaid, each Party hereby undertakes to comply with all relevant provisions of the POPI Act and any other applicable data protection laws. The Client further agrees to comply with all CSIR's reasonable internal governance requirements pertaining to data protection.
- 16.2 Each Party consents to the other Party making such information available to those who provide products or services to such parties (such as advisers, regulatory authorities, governmental or quasi-governmental organisations and potential purchasers of such Party or any part of their business).
- 16.3 The Client consents to the transfer of such information to CSIR's business contacts outside South Africa in order to further its business interests.
- 16.4 While performing any activity where a Party is handling personal information as a "responsible party" (as defined in the POPI Act), each Party undertakes that it will process the personal information strictly in accordance with the terms of the POPI Act, this Contract, and the other Party's instructions from time to time, and take appropriate operational measures to safeguard the data against any unauthorised access.
- 16.5 Each Party acknowledges that in the course of conducting business with each other, each

Party intends to maintain and process personal information about the other Party in an internal database. By signing this Contract, each Party consents to the maintenance and processing of such personal information.

- 16.6 Where relevant, the Client shall procure that all of its personnel, agents, representatives, contractors, sub-contractors and mandataries shall comply with the provisions of this clause 16 (Personal Information). The CSIR shall be entitled on reasonable notice to conduct an inspection or audit Client's compliance with the requisite POPI Act safeguards.

17 INDEMNITY

If a bidder breaches the conditions of this bid and, as a result of that breach, the CSIR incurs costs or damages (including, without limitation, the cost of any investigations, procedural impairment, repetition of all or part of the bid process and/or enforcement of intellectual property rights or confidentiality obligations), then the bidder indemnifies and holds the CSIR harmless from any and all such costs which the CSIR may incur and for any damages or losses the CSIR may suffer.

18 TAX COMPLIANCE

No tender shall be awarded to a bidder who is not tax compliant. If a recommended bidder is not tax compliant, the bidder will be notified in writing of their non-compliant status and the bidder will be requested to submit written proof from SARS of their tax compliant status or proof that they have made an arrangement to meet their outstanding tax obligations within seven (7) working days. Should they fail to do so CSIR will reject their bid.

The CSIR reserves the right to withdraw an award made, or cancel a contract concluded with a successful bidder in the event that it is established that such bidder was in fact not tax compliant at the time of the award or has submitted a fraudulent Tax Clearance Certificate to the CSIR, or whose verification against the Central Supplier Database (CSD) proves non-compliant. The CSIR further reserves the right to cancel a contract with a successful bidder in the event that such bidder does not remain tax compliant for the full term of the contract.

19 LIMITATION OF LIABILITY

A bidder participates in this bid process entirely at its own risk and cost. The CSIR shall not be liable to compensate a bidder on any grounds whatsoever for any costs incurred or any damages suffered as a result of the Bidder's participation in this Bid process.

20 MISREPRESENTATIONS DURING THE LIFECYCLE OF THE CONTRACT

- 20.1 The bidder should note that the terms of its Tender will be incorporated in the proposed contract by reference and that the CSIR relies upon the bidder's Tender as a material representation in making an award to a successful bidder and in concluding an agreement with the bidder.
- 20.2 It follows therefore that misrepresentations in a Tender may give rise to service termination and a claim by the CSIR against the bidder notwithstanding the conclusion of the Service Level Agreement between the CSIR and the bidder for the provision of the Service in question. In the event of a conflict between the bidder's proposal and the Service Level Agreement concluded between the parties, the Service Level Agreement will prevail.

21 DISCLAIMER

This RFQ is a request for Quotations only and not an offer document. Answers to this RFQ must not be construed as acceptance of an offer or imply the existence of a contract between the parties. By submission of its proposal, bidders shall be deemed to have satisfied themselves with and to have accepted all Terms & Conditions of this RFQ. The CSIR makes no representation, warranty, assurance, guarantee or endorsements to bidder concerning the RFQ, whether with regard to its accuracy, completeness or otherwise and the CSIR shall have no liability towards the bidder or any other party in connection therewith.

22 NATIONAL TREASURY CENTRAL SUPPLIER DATABASE

- 22.1 Bidders are required to be registered on the Central Supplier Database and the National Treasury shall verify the bidder's tax compliance status through the Central Supplier Database. Registrations can be completed online at: www.csd.gov.za;
- 22.2 Where Consortia / Joint Ventures / Sub-contractors are involved, each party must be registered on the Central Supplier Database and their tax compliance status will be verified through the Central Supplier Database.

ANNEXURE A

DETAILED SPECIFICATIONS

This specification covers the detailed design, engineering, supply of materials, fabrication, assembly, finishing, quality control, testing, delivery, and commissioning (if applicable) of the specified custom containers. Bidders are required to provide comprehensive proposals demonstrating their capacity to meet or exceed all specified requirements.

Custom-Made Container (External Dimensions: 3000mm W x 12000mm L)

Note: The base structure for this custom build should follow the principles of a 40ft High Cube (HC) container for height and structural integrity.

Dimensions & Structure

- a) External Length: 12,000 mm (exact).
- b) External Width: 3,000 mm (exact).
- c) External Height: Minimum 2,896 mm (equivalent to High Cube height).
- d) Internal Length: [To be determined by successful Bidder, based on external dimensions minus specified wall thicknesses. Target range: approximately 11,850 mm - 11,900 mm].
- e) Internal Width: [To be determined by successful Bidder, based on external dimensions minus specified wall thicknesses. Target range: approximately 2,850 mm - 2,900 mm].
- f) Internal Height: [To be determined by successful Bidder, based on external height minus floor/ceiling thickness. Target range].
- g) Structure: Custom-built steel frame, certified by a South African Professional Engineer (Pr. Eng.) in accordance with relevant SANS standards.
- h) Painting: Full exterior paint (RAL colour will be specified after successful bidder appointed but cost provisions should be made) over an anti-corrosive primer. Roof to receive additional sealant for waterproofing.

Doors & Openings

- a) Main Entry/Exit Door. Heavy-duty, insulated steel double-leaf hinged door, outward opening. Clear Opening Dimensions (Width x Height): Minimum 1800 mm x 2000 mm.
- b) Customer Service/Selling Hatch: Top-hinged steel hatch, opening outwards and upwards.
- c) Clear Opening Dimensions (Width x Height): Minimum 2400 mm x 1200 mm. Must be weather-tight when closed.
- d) Windows: Four (4) custom aluminium frame windows (e.g., top-hung awning or horizontal sliding) with 6.38mm laminated safety glass and integrated insect screens.
- e) Dimensions for each: 900mm x 900mm. Location to be specified by CSIR on final drawings.

Interior Finishes

- a) Insulation & Panelling: Fully insulated with minimum 40mm insulated panels. Finish: White Chromadeck panelling with aluminium trimmings.
- b) Flooring: Heavy-duty, non-slip rubberized flooring, fully sealed with coved skirting.
- c) Furniture: One Stainless steel workbenches/tables (1.2m long) on castor wheels shall be supplied with ten plastic chairs with adequate back support.
- d) 1800Lx1800mmH, 400mm Width Light Duty Steel Racking shall be supplied and installed according to manufacturer's specifications and as per drawing.
- e) Provision for 20 times 20L capacity white plastic buckets each is required with full closing plastic lids and one 240L general waste bin with liners and wheels needs to be supplied.

Plumbing & Water System

- a) Internal Sinks: One (1) stainless steel double sink unit with one cold mixer tap only, integrated into a countertop and an additional sink to be placed externally as well with shared water inlet piping from rainwater harvesting system as described below with a single combined drain external outlet for wastewater collection.
- b) Rainwater Harvesting & Storage System: The container must be equipped with a rainwater harvesting system, including guttering system from the roof canopy structure described below, one (1) 5 000-litre ("JoJo Tank" or equivalent) water storage tank, a water filtration system, and an on-demand pressure pump to supply all water fixtures. Provision for connection to a additional future equivalent water storage tank as a backup should be made.

Electrical System

- a) Compliance: Fully compliant with SANS 10142-1. All electrical work to be carried out by a qualified electrician and issued with a Certificate of Compliance (CoC).
- b) DB Box: One (1) lockable distribution board with all necessary breakers and earth leakage.
- c) Lighting: Three (3) internal light fittings with holders (e.g., energy-efficient LED panel lights or batten fittings).
- d) Light Switch: One (1) light switch for internal lighting control.
- e) Plugs: Three (3) double 16A, 3-pin SA SANS 164-1 socket outlets, strategically located.
- f) Appliances (Supplier Provided): One (1) Electric Stove: 2-plate counter-top electric stove.
- g) Power Rating: To be provided in technical proposal, ensuring compatibility with solar system.
- h) One (1) Fridge/Freezer dual capability: Capacity and Power Rating: To be provided in technical proposal, ensuring >500L internal capacity and compatible with solar system.
- i) One (1) Mass Balance: Capacity and Power Rating: To be provided in technical proposal, <100kg maximum weight capacity (up to 2 decimal places accuracy) and preferably battery operated or if not, can be connected electrically to a solar system.
- j) One (1) food processing blender: Capacity and Power Rating: To be provided in technical proposal, ensuring >20L minimum capacity and preferably battery operated or if not, can be connected electrically to solar system.
- k) Dedicated circuits for high-load items (e.g., stove, freezer).

Off-Grid Solar Power System (Mandatory Requirement).

- a) The container must be equipped with a self-sufficient solar power system capable of running all specified equipment. Bidder's load calculations must justify the system sizing.

Minimum specifications:

- Battery Storage: Minimum 5kWh Lithium-ion battery bank.
- Inverter: 5kW Off Solar Inverter (or higher if required by load calculations).
- Solar Panels: Minimum six (6) 550W (or equivalent for ~3.3kWp total) solar panels with robust, roof-mounted racking.
- Housing: A dedicated, ventilated internal equipment partition to securely house the inverter, batteries, and control gear.
- Backup: Provision for connection to a backup petrol generator with a suitable jerry can for petrol storage. An optional line item for the supply of a 5-10kW petrol generator may be included in the financial proposal.

External Features Canopy and Fencing:

- a) An IBR profile roof canopy must be supplied and installed and should be a gutter downpipe to the supplied horizontal JoJo tank.
- b) Size: To extend a minimum of 1,500mm from the container wall.
- c) Coverage: To run along the length of the container, providing cover over the windows and service hatch.
- d) Installation: Due to transport-width restrictions, the canopy may require on-site installation, and this must be included in the cost.
- e) Suitable Fencing to be provided per supplied drawing.

Transportation, Site Preparation & Exclusions

Transportation

- a) Bidder is responsible for all transport costs to the 10 selected final installation sites in the Peddie area of the Eastern Cape Province. **(Peddie is a town in the Ngqushwa Local Municipality within the Amathole District Municipality in the Eastern Cape province of South Africa.)**
- b) The container unit might require abnormal load transport and the bidder must demonstrate experience and include all associated costs (permits, escorts).

On-Site Installation

- a) Bidder is responsible for all on-site work, including canopy installation. Note, no electrical power is available on-site and supplier to provide their own power supply for welding equipment etc.

Exclusions

- a) The CSIR is responsible for providing an accessible site. This tender excludes any civil works, foundations, or final service connections to municipal grids as it's a complete off-grid installation.

Site Requirements from Contractor

- a) The CSIR will provide site access for installation purposes. The contractor must provide for their own staff's ablution and accommodation facilities. The awarded Bidder must cater for a foundational solution for placement of the containers per each site.

Warranty

- a) A minimum **12-month warranty** on all welding, workmanship, and supplied components is required. Fair wear and tear is excluded.

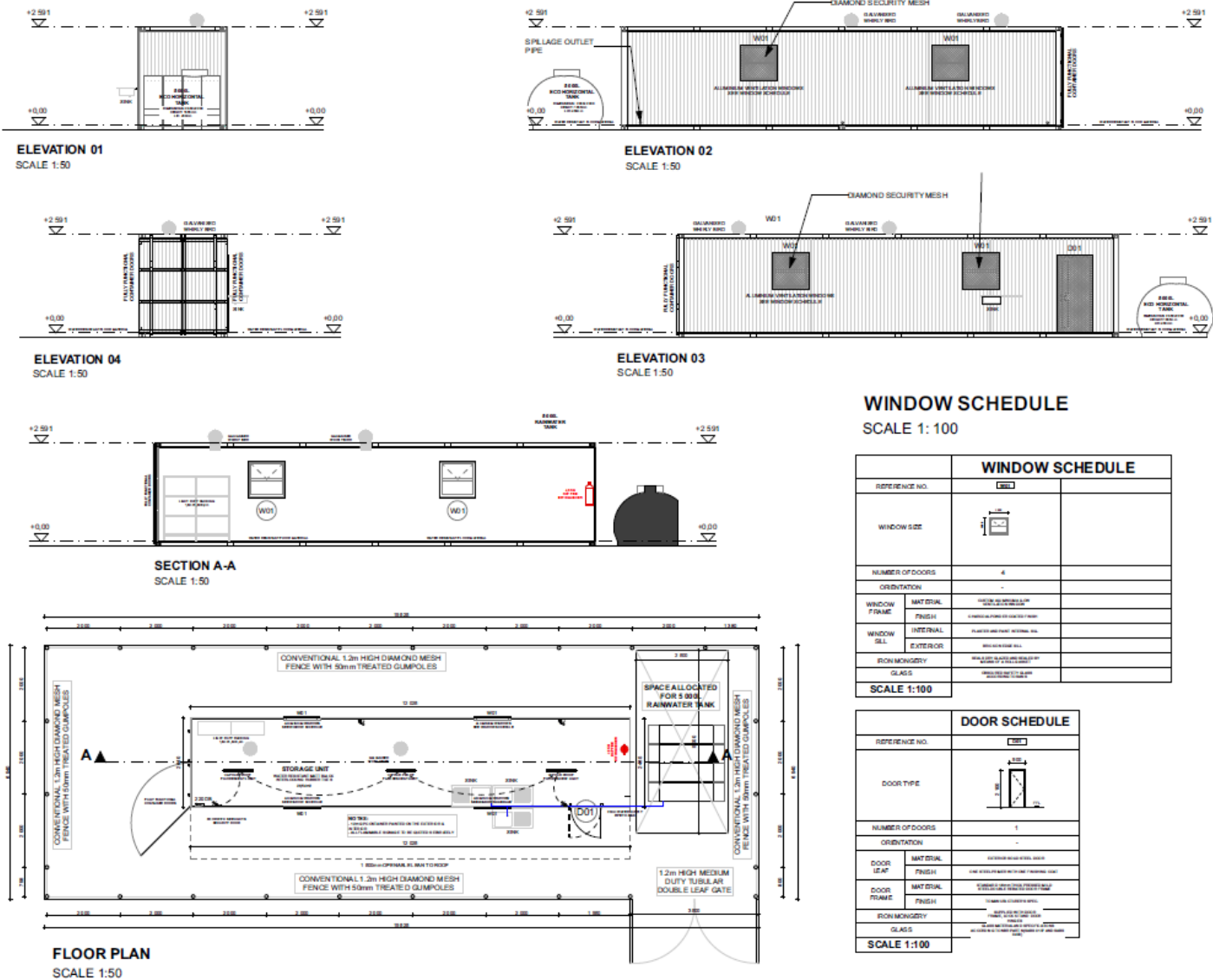
- a) All work shall comply with the latest editions of relevant South African National Standards (SANS), International Standards (ISO), and local building regulations, including but not limited to: **SANS 10400-XA:2011 (The application of the National Building Regulations - Part XA: Energy Usage in Buildings)** and other relevant parts of SANS 10400 as applicable for the specific use of the containers.
- b) **SANS 10142-1 (The wiring of premises - Part 1: Low-voltage installations. ISO 9001 (Quality Management Systems) (preferred for manufacturer)**. Other relevant SANS for materials, safety, and specific installations (e.g., plumbing, fire safety, and any specific standards for food handling or agricultural research). Approved drawings to be supplied.

Submission Requirements

- a) Costing Documentation: Detailed description of proposed design, materials, manufacturing process, and adherence to specifications.
- b) Project Plan: Proposed timeline, resource allocation, and key milestones and final construction drawings and specifications needs to be supplied.
- c) Quality Control Plan: Outline of quality assurance procedures during fabrication and testing.
