## SECTION A – TECHNICAL INFORMATION

### 1 INTRODUCTION

The Council for Scientific and Industrial Research (CSIR) is one of the leading scientific research and technology development organisations in Africa. In partnership with national and international research and technology institutions, CSIR undertakes directed and multidisciplinary research and technology innovation that contributes to the improvement of the quality of life of South Africans. The CSIR's main site is in Pretoria while it is represented in other provinces of South Africa through regional offices.

### 2 BACKGROUND

SANReN is a major research infrastructure initiative of the Department of Science and Innovation (DSI) with the responsibility to connect all research, education and innovation institutions to a high-speed telecommunications network.

The CSIR is mandated to connect all qualifying research and higher education institutions through the SANReN high speed network. The SANReN has a requirement to provide diverse network connectivity to the Mangosuthu University of Technology main campus in Umlazi.

The CSIR has been issued with a Licence Exemption in terms of the regulations for Licence exemption as defined in the Electronic Communications (EC) Act no 36 of 2005, for the establishment of SANReN. This licence exemption entitles the CSIR to build and acquire its own communications infrastructure, or to lease connectivity and capacity from licensed telecommunications operators holding Electronic Communication Network Service (ECNS) licences issued in term of the EC Act.

This document describes the general terms and conditions to which all bidders must comply.

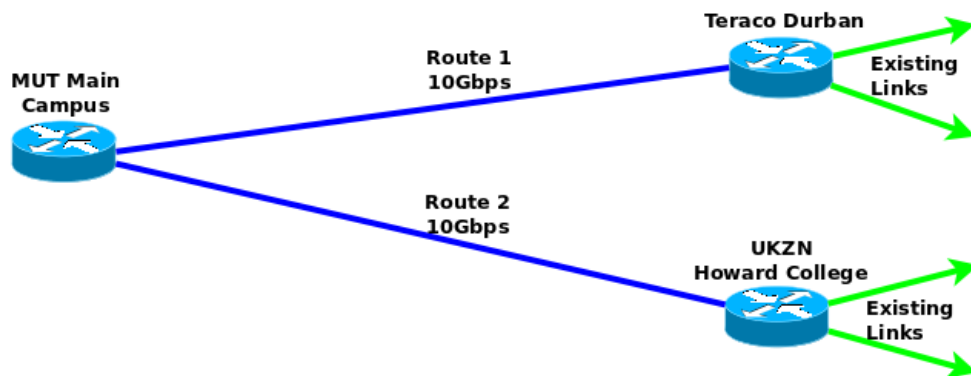
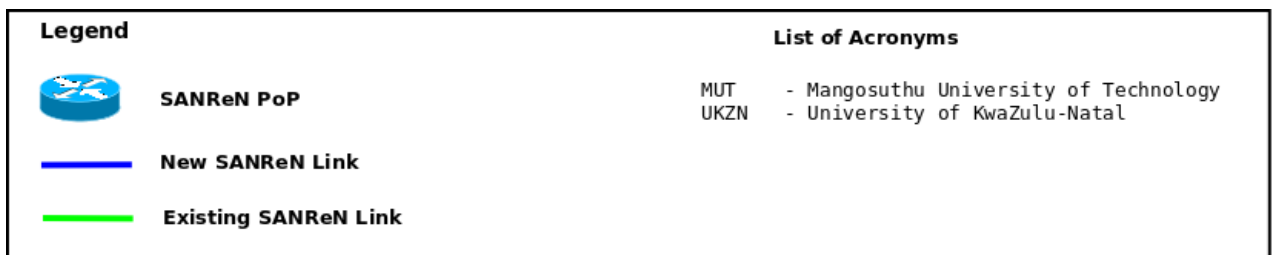
### 3 INVITATION FOR PROPOSAL

Proposals are hereby invited for the supply of two **non-overlapping / diverse routes** of fixed-line managed bandwidth links of 10Gbps capacity to Mangosuthu University of Technology (MUT). As a result of this tender process, the intention is to procure **only two** managed bandwidth links. The

links chosen will be two physically diverse routes (no overlap) between the Mangosuthu University of Technology (MUT) main campus and Teraco Durban Datacentre link and the MUT to UKZN Howard College campus as detailed in *Table 1* and schematically illustrated in *Diagram 1* below:

#### 4 REQUIREMENT LEVEL KEYWORDS

4.1 To eliminate ambiguity, bidders are to interpret the meaning of technical requirements using the keywords; "must", "must not", "required", "shall", "shall not", "should", "should not", "recommended", "may", and "optional", as defined by the IETF RFC (Request For Comments) document designated as RFC2119.

## 5 PROPOSAL SPECIFICATION

- 5.1 CSIR requests bidders to provide two **non-overlapping / diverse routes** for the managed bandwidth point to point links to MUT with 10Gbps bandwidth capacity as stated in the Technical Requirements (Annexure A).
- 5.2 **As a result of this tender process, the best two routes will be procured. The links chosen will be two physically diverse routes (no overlap) and may result in an award to more than one bidder.**
- 5.3 Bidders must provide a schedule with timelines for the delivery of the link(s).
- 5.4 Structure of this RFP:
- 5.4.1 This document consists of a main RFP document and four (4) Annexures. i.e. Annexure A – Technical requirements, Annexure B – Technical compliance matrix, Annexure C – Pricing Schedule and Annexure D – Returnable Documents Checklist
- 5.4.2 Bidders must provide all the documentation requested in the main RFP once only. The Technical and Price responses must not be included in the main RFP, but in respective Technical and pricing matrices as per the bid file structure in Table 4.
- 5.4.3 Refer to Section 10 below for details on how the bidders must structure their responses.
- 5.5 The bidders must cater for an access build if it is required for the solution.
- 5.6 Bidders must provide an end-to-end solution, i.e. from one ODF to the next ODF.
- 5.7 Bidders must provide pricing that is inclusive of the fibre lease and maintenance and support for a period of 36 months and 60 months.

5.8 Bidders who intend to bid for this RFP must complete the Technical Compliance Matrix. If a bidder intends to provide a solution for more than one route, the Technical Compliance Matrix for each route needs to be completed.

5.9 The CSIR reserves the right not to award the second link if no suitable solution can be found.

## 6 FUNCTIONAL EVALUATION CRITERIA

6.1 The bidder **must** complete the technical compliance matrix in full, which is a mandatory submission and is found in Annexure B. The technical compliance matrix will facilitate the technical evaluation of the proposed solution(s). Bidders who do not submit a completed matrix will not be evaluated.

### 6.2 Technical Requirements

6.2.1 The bidder must respond to the specific technical requirements of the project as detailed in *Annexure A - Technical Requirements*.

6.2.2 Proposals with technical points of less than the predetermined minimum overall percentage of 70% and a score of 0 on any individual criteria as stated in the Technical Compliance Matrix spreadsheet (Annexure B) will be eliminated from further evaluation.

6.2.3 The evaluation of the technical detail of the proposal will be based on the following criteria in Table 2. There are different weights assigned to each criterion. A possible score of 0, 5 or 10 for each criterion, based on non-compliance, partial compliance, or full compliance with the specific criterion. Some criteria shown below require full compliance to pass.

6.2.4 Refer to **Annexure B** for the scoring sheet that will be used to evaluate technical compliance.

### 6.3 Route Diversity Requirement

6.3.1 The CSIR is looking for two physically diverse routes to Mangosuthu University of Technology (MUT) main campus.

6.3.2 The two links can either be from a single supplier or multiple suppliers.

6.3.3 The award of the tender to either single or multiple suppliers will be based on the following:

- Diversity of the routes

- Cost considerations based on the most cost-effective link combinations that is most cost effective and diverse links.

## **7 ELIMINATION CRITERIA**

Proposals will be eliminated under the following conditions:

- Proposals submitted after the deadline;
- Proposals submitted at incorrect email address;
- Failure to submit a signed declaration form;
- Failure to complete the Technical Compliance Matrix in full;
- Failure to complete the Pricing Schedule; and
- Failure to submit a kml document showing the link route.
- National Treasury Restricted Suppliers

## **8 NATIONAL TREASURY CENTRAL SUPPLIER DATABASE (CSD) REGISTRATION**

Before any negotiations will start with the winning bidder it will be required from the winning bidder to:

- be registered on the National Treasury's Central Supplier Database (CSD). Registrations can be completed online at: [www.csd.gov.za](http://www.csd.gov.za);
- provide the CSIR of their CSD registration number; and
- provide the CSIR with a certified copy of their B-BBEE certificate (RSA suppliers only). If no certificate can be provided, no points will be scored during the evaluation process.
- provide the CSIR with a valid copy of tax certificate.

## SECTION B – TERMS AND CONDITIONS

### 9 PROPOSAL SUBMISSION

The CSIR requires that all tender submissions be submitted electronically. Should tender file size exceed 25 MB, bidders can submit tender in multiple emails. Use the tender number **3505/01/02/2022** and description of the tender as the subject on your email.

- 9.1 All proposals must be submitted at: [tender@csir.co.za](mailto:tender@csir.co.za).
- 9.2 All proposals are to be clearly marked with the RFP number under the subject on each e-mail submission.
- 9.3 Proposals must consist of three parts, each of which is submitted in a separate e-mail package clearly marked with the RFP Number and the description of the tender:
  - **PART 1:** General Terms, Conditions and Documentation: RFP No. **3505/01/02/2022**
  - **PART 2:** Technical Proposals, Technical Compliance Matrix: RFP No. **3505/01/02/2022**

9.4 Bidders must not embed files within other files, e.g. .pdf file(s) embedded within a Word file.

- 9.5 Proposals submitted by companies must be signed by a person or persons duly authorised.
- 9.6 The CSIR will award the contract to qualified bidder(s) whose proposal is determined to be the most advantageous to the CSIR, taking into consideration the technical solution, price and B-BBEE.

## 10 TENDER PROGRAMME

## 11 DEADLINE FOR SUBMISSION

Proposals shall be submitted to [tender@csir.co.za](mailto:tender@csir.co.za) no later than the closing date of **Tuesday, 01 February 2022 at 16h30**.

Where a proposal is not received by the CSIR by the due date and time via the stipulated email address, it will be regarded as a late tender. Late tenders will not be considered.

## 12 AWARDING OF TENDERS

12.1 Awarding of tenders will be published on the National Treasury e-tender portal and CSIR website. No letters of regret will be sent out.

## 13 EVALUATION PROCESS

13.1 **Evaluation of proposals**

All proposals will be evaluated for technical capability, price and B-BBEE. Based on the results of the evaluation process and upon successful negotiations, the CSIR will approve the awarding of the contract to successful bidder(s).

A two-phase evaluation process will be followed.

- The first phase includes the evaluation of the **elimination criteria** and **technical criteria**.
- The second phase includes the evaluation of **price** and **B-BBEE** status.

Pricing Proposals will only be considered after technical capability phase has been evaluated and accepted. Only proposals that achieved the specified minimum qualification scores for technical capability will be evaluated further using the preference points system.

### 13.2 Preference points system

The **80/20** preference point system will be used where 80 points will be dedicated to price and 20 points to B-BBEE status.

Bidders are encouraged to provide the CSIR with a certified copy of their B-BBEE certificate. If no certificate can be provided, no points will be scored during the evaluation process.

## 14 PRICING PROPOSAL

14.1 Pricing proposal must be cross-referenced to the respective sections in the Technical Proposal. Any options offered must be clearly labelled. Separate pricing must be provided for each option offered to ensure that pricing comparisons are clear and unambiguous.

14.2 Pricing Schedule Matrix (Annexure C) is a mandatory submission designed to facilitate evaluation. Separate pricing must be provided for each option offered to ensure that pricing comparisons are clear and unambiguous.

14.3 Price needs to be provided in South African Rand (excl. VAT), with details on price elements that are subject to escalation and exchange rate fluctuations clearly indicated.

14.4 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable.

14.5 Price should indicate the Rand/Dollar exchange rate and the cost of the forward cover valid for six (6) Months from the date of the proposal if applicable.

14.6 Only firm prices\* will be accepted during the tender validity period. Non-firm prices\*\* (including prices subject to rates of exchange variations) will not be considered.

\* Firm price is the price that is only subject to adjustments in accordance with the actual increase or decrease resulting from the change, imposition, or abolition of customs or excise duty and any other duty, levy, or tax which, in terms of a law or regulation is binding on the contractor and demonstrably has an influence on the price of any supplies, or the rendering costs of any service, for the execution of the contract;

\*\* Non-firm price is all prices other than "firm" prices.

14.7 Payment will be according to the CSIR Payment Terms and Conditions.

14.8 Pricing Expectation

- Bidders are reminded that the CSIR expects all solutions offered to be "Wholesale Transmission Services" at carrier quality, availability and pricing levels normally associated with such services sold on to licensed providers of electronic communications service providers.
- Since the SANReN network is a research and education network, and will not be used by the CSIR in a "for profit" sense, bidders are encouraged to provide discounted pricing below the "wholesale transmission services" rate. e.g. E-rate, education discounts.

## **15 VALIDITY PERIOD OF PROPOSAL**

14.1 Each proposal shall be valid for a minimum period of six (6) months calculated from the closing date.

## **16 APPOINTMENT OF SERVICE PROVIDER**

16.1 The contract will be awarded to the bidder who scores the highest total number of points during the evaluation process, except where the law permits otherwise.

16.2 Appointment as a successful service provider shall be subject to the parties agreeing to mutually acceptable contractual terms and conditions. In the event of the parties failing to reach such agreement CSIR reserves the right to appoint an alternative service provider.

## **17 ENQUIRIES AND CONTACT WITH THE CSIR**

Any other contact with CSIR personnel involved in this tender is not permitted during the RFP process other than as required through existing service arrangements or as requested by the CSIR as part of the RFP process.

## **18 MEDIUM OF COMMUNICATION**

All documentation submitted in response to this RFP must be in English.

## **19 COST OF PROPOSAL**

Bidders are expected to fully acquaint themselves with the conditions, requirements and specifications of this RFP before submitting proposals. Each bidder assumes all risks for resource commitment and expenses, direct or indirect, of proposal preparation and participation throughout the RFP process. The CSIR is not responsible directly or indirectly for any costs incurred by bidders.

## **20 CORRECTNESS OF RESPONSES**

20.1 The bidder must confirm satisfaction regarding the correctness and validity of their proposal and that all prices and rates quoted cover all the work/items specified in the RFP. The prices and rates quoted must cover all obligations under any resulting contract.



20.2 The bidder accepts that any mistakes regarding prices and calculations will be their own risk.

## **21 VERIFICATION OF DOCUMENTS**

21.1 Bidders should check the numbers of the pages to satisfy themselves that none are missing or duplicated. No liability will be accepted by the CSIR in regard to anything arising from the fact that pages are missing or duplicated.

21.2 The CSIR requires that all bidders to submit proposals electronically to CSIR at [tender@csir.co.za](mailto:tender@csir.co.za).

21.3 Pricing schedule and B-BBEE credentials should be submitted with the proposal, but as a separate document and no such information should be available in the technical proposal.

## **22 ANNEXURE D - RETURNABLE DOCUMENTS CHECKLIST**

The bidder must complete Annexure D and return the necessary documents as per the annexure.

## **23 SUB-CONTRACTING**

23.1 A bidder will not be awarded points for B-BBEE status level if it is indicated in the tender documents that such a bidder intends sub-contracting more than 25% of the value of the contract to any other enterprise that does not qualify for at least the points that such a bidder qualifies for, unless the intended sub-contractor is an exempted micro enterprise that has the capability and ability to execute the sub-contract.

23.2 A bidder awarded a contract may not sub-contract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level than the person concerned, unless the contract is sub-contracted to an exempted micro enterprise that has the capability and ability to execute the sub-contract.

## **24 ADDITIONAL TERMS AND CONDITIONS**

- 24.1 A bidder shall not assume that information and/or documents supplied to CSIR, at any time prior to this request, are still available to CSIR, and shall consequently not make any reference to such information document in its response to this request.
- 24.2 Copies of any affiliations, memberships and/or accreditations that support your submission must be included in the tender.
- 24.3 In case of a proposal from a joint venture, the following must be submitted together with the proposal:
- Joint venture Agreement including split of work signed by both parties;
  - The original or certified copy of the B-BBEE certificate of the joint venture;
  - The Tax Clearance Certificate of each joint venture member;
  - Proof of ownership/shareholder certificates/copies; and
  - Company registration certificates.
- 24.4 An omission to disclose material information, a factual inaccuracy, and/or a misrepresentation of fact may result in the disqualification of a tender, or cancellation of any subsequent contract.
- 24.5 Failure to comply with any of the terms and conditions as set out in this document will invalidate the Proposal.
- 24.6 During Contracting, the CSIR will negotiate with the highest scoring bidder to convert any Partial Compliance Scores that they have received in their tender response to become fully compliant. This is done to ensure that the bidder fully complies with all of the CSIR's requirements. Furthermore, this will be done at no additional cost to the CSIR.

## **25 CSIR RESERVES THE RIGHT TO**

- 25.1 Extend the closing date;
- 25.2 Verify any information contained in a proposal;
- 25.3 Request documentary proof regarding any tendering issue;
- 25.4 Give preference to locally manufactured goods;
- 25.5 Appoint one or more service providers, separately or jointly (whether or not they submitted a joint proposal);
- 25.6 Award this RFP as a whole or in part to a single bidder or multiple bidders;
- 25.7 Cancel or withdraw this RFP as a whole or in part.
