 - The scope includes all audits prior to the issuance of the required certificates.
 - The scope includes the issuance of certificates for AS/EN9100.
 - The 1st and 2nd Annual Surveillance audits must NOT BE INCLUDED in the scope.

2 QUOTATION REQUIREMENTS

- 2.1 The service provider (Certification Board) must have at least 3 years' worth of experience in the certification of AS/EN9100.
- 2.2 Proof should be submitted with the application that the service provider is accredited by the International Aerospace Quality Group (IAQG) or accredited with a Board that is recognised by the IAQG.

Note: The quotation should include the Certification Audit only, and **NOT** the Surveillance Fees for Year 1 and 2

3 ADDITIONAL REQUIREMENTS

- 5.2 Provide valid original or certified B-BBEE certificate issued by SANAS accredited provider or CIPC, or valid sworn affidavit on DTI template
- 5.3 Indicate CSD number (National Treasury Central Supplier Database) on quotation. If not registered yet on CSD, use www.csd.gov.za to register.
- 5.4 No order will be issued or no contract will be signed without a valid CSD number.

6 PRICING QUOTATION

- 6.1 Price needs to include details on elements that are subject to escalation and exchange rate fluctuations (if applicable).
- 6.2 Price should include additional cost elements such as freight, insurance until acceptance, duty where applicable, etc.
- 6.3 Payment will be according to the CSIR Payment Terms and Conditions.

- No goods and/or services should be delivered to the CSIR without an official CSIR Purchase order. CSIR purchase order number must be quoted on the invoice. Invoices without CSIR purchase order numbers will be returned to supplier.
